TERMS AND AGREEMENTS

- 1.) The instrument may be rented by the rental periods listed on front with rent payable in advance.
- 2.) All rental fees paid may be applied toward purchase of that instrument as long as account is current and in good standing. A \$5.00 late fee is charged for payments not received within ten (10) days of the date due per month.
- 3.) CHECK POLICY: By using a check for payment, you agree to the following terms: In the event your check is dishonored or returned for any reason, you authorize us to electronically (or by paper-draft) represent the check to your bank account for collection of the amount of the check plus any applicable fees as permitted by state law.
- 4.) Renter understands that Royal Music Co., Inc. retains title of ownership and reserves the right to regain possession of the instrument on site at any time rent payments are more than ten (10) days past due. In this event, Renter must make the late payment, including all late fees, within 10 days of the repossession to reinstate the agreement. Upon default, Royal Music Co., Inc. reserves the right to terminate the agreement and obtain possession of the instrument. The Renter shall not own the property and has no right to sell, sublease, pawn, pledge, encumber or otherwise dispose of the property until all amounts due under the terms of this agreement are paid in full.
- 5.) In the event of default, the Renter agrees to pay all attorneys' fees and/or costs of collection whether or not a suit is filed.
- 6.) A repair and maintenance policy (NOT INSURANCE) is available through this contract. THE RENTER IS RESPONSIBLE FOR LOSS, THEFT AND/OR DAMAGE OF THE INSTRUMENT.
- 7.) The Renter MUST notify the home office of Royal Music Co., Inc. if they wish to end this agreement. To terminate this agreement, Renter must return the instrument to Royal Music Co., Inc., 830 Fairview Ave, Bowling Green, KY 42101 or to a designated agent thereof. Leaving an instrument in an unauthorized location without proper notification of the home office of Royal Music Co., Inc. does not constitute returning it to Royal Music Co., Inc. or a designated agent thereof. Confirmation of termination, including any amounts of past due payments outstanding, will be mailed to the renter's address on record with the home office of Royal Music Co., Inc. This agreement shall not be considered terminated and charges will continue to accrue unless the termination prerequisites set forth in this paragraph have been met.
- 8.) Upon return to Royal Music Co., Inc. according to the terms above, renter may reinstate the agreement within 30 days of voluntarily returning the instrument if the instrument is returned undamaged to Royal Music Co., Inc. within the 10-day grace period of the payment due.
- 9.) I understand that: (1) this rental program is an issuance of credit, (2) all applications are subject to credit approval, and (3) Royal Music Co., Inc. reserves the right to review my credit history by credit report. I understand that this agreement does not constitute a binding contract until it is accepted by Royal Music Co., Inc. at its home office.

RENTER'S RETURN PRIVILEGE: It is further agreed that the Renter may at any time return the Merchandise to Royal Music Co. Inc. in good condition, and upon such return agrees to pay all payments in default in order to be released any further liability under this agreement, as to said Merchandise. Royal Music Co., Inc. shall retain all amounts paid hereunder as consideration for the use of the Merchandise.

NOTICE TO THE RENTER: (A) DO NOT AGREE TO THESE TERMS BEFORE YOU READ THEM. (B) YOU HAVE THE RIGHT TO PAY IN ADVANCE THE FULL AMOUNT DUE. ROYAL MUSIC CO., INC.
